PROGRAMME OVERVIEW

The Nauru Economic and Climate Resilience Citizenship Programme was established under the Nauru ECRCP Act 2024 and is administered by the Nauru Program Office (NPO). It is one of the Pacific's newest citizenship by investment initiatives, with contributions flowing directly to Nauru's Treasury Fund in support of climate and development priorities.

Global Citizenship Partners is a licensed agent for this programme. Nauru is the world's smallest independent republic – a 21 km² island in the central Pacific – actively investing in economic diversification, renewable energy and climate resilience.

KEY BENEFITS

No minimum stay – No obligation to visit or reside in Nauru – ever.

Unrestricted dual citizenship – No restrictions on holding other citizenships simultaneously.

Fast processing – Most clients receive citizenship within 3–4 months of submission.

Family inclusive – Spouse, children, parents and siblings can all be included.
